An Ordinance levying taxes for all road purposes for the Downers Grove Township Road District, DuPage County, Illinois, for the tax year 2017, collectible in 2018.

BE IT ORDAINED by the Board of Trustees of Downers Grove Township, DuPage County, Illinois, as follows:

SECTION 1.
