In 2018 we have the Downers Grove Township issued financial statements and in compliance with all accounting principles and all applicable governmental accounting standards, therefore Klein Hall was able to issue an unmodified opinion as in previous years. Along with the financial statements, Board members were provided copies of the required Communication letter. Trustee Donner has been working with Mr. Duenser and stated that this will continue with the accrual process so they are completed throughout the year. Trustee Donner asked Mr. Duesner about the pension liability and having it flip around to a net asset and if he is seeing this in other townships as a result of investment yields going up? Mr. Duesner stated he has seen this in a couple townships because historically IMRF has been well funded. Trustee Donner asked if interest rates were to go up

another 2% over the next 2 years, is there any concern and how would this affect our pension liability? Mr. Duesner stated this question could be answered more directly by an investment advisor.
