  - A. Park Districts
    - Sheri Henderson reported that BRPD will NOT be doing Tax preparation for seniors this year; Clarendon Hills Park District is delivering some food items to local residents
    - b. Beth Hahn of The Community House in Hinsdale reported that Ken from AARP will be doing tax prep for seniors in 2 appointments in the same week (1/2hr. and 15 minutes)- waiting to get dates for this; "Sit Up and Get Fit" will begin in February; Summer Brochure Guides will include Pickle Ball, Open Play and Fitness; perhaps small groups in April?
  - B. First Responders

- a. Lynn Dralle reported that all vaccines are now done for their first responders; she also stated that most of the local nursing homes had completed their vaccines also; no classes as of yet but a possible virtual academy in April;
- C. Julie Larson Alerted us to the fact that Loaves and Fishes in Naperville is doing tax prep for seniors by appointment-she is sending a flyer that Cathy can email to all members (VITA 630.355.3663 X100); there is a reduced number of appts. available; there are some free home services available call: 630.620.0804; Dupage County Fairgrounds will soon become a vaccination site instead of a testing site
- D. George Goodwin reported that AARP expects its classes and services to restart soon; George will update Cathy on tax prep locations when he gets them; George also stated that the Global Council on Brain Health said that exercise is extremely important
- E. Elaine Furjanic of Community Adult Day stated that they currently can accommodate about half of their "normal" clients
- F. Renee Faur stated that essential caregivers and family members can now come in to visit their loved ones; seniors are becoming complacent and sedentary and need their family visits
