

**ORDINANCE NO.19/20
DOWNERS GROVE TOWNSHIP TAX LEVY ORDINANCE**

An ordinance levying taxes for all corporate purposes for DOWNS GROVE TOWNSHIP, Illinois, for the tax year 2018, collectible in 2019.

BE IT ORDAINED by the BOARD OF TRUSTEES OF DOWNS GROVE TOWNSHIP, DuPage County, Illinois, as follows:

Section 1: That the sum of TWO MILLION FIVE HUNDRED AND FORTY-FIVE THOUSAND and 00/100 DOLLARS (\$2,545,000.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized for the current year, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law for such purposes as the General Fund, General Assistance and IMRF Fund for the fiscal year beginning March 1, 2019 and ending February 28, 2020.

Section 2: That the amount levied for each object and purpose shall be as follows:

General Fund	\$2,529,000.00
General Assistance	\$ 8,000.00
IMRF Fund	8,000.00
Total	\$2,545,000.00

Section 3: That the Clerk shall make and file with the County Clerk of the County of DuPage, on or before the time required by law, a duly certified copy of this ordinance.

Section 4: That if any section, subdivision or sentence of this ordinance shall, for any reason, be held invalid or be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

Section 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.

Adopted this 18th day of October 2018, by the Board of Trustees of Downers Grove Township.
