An ordinance levying taxes for all corporate purposes for DOWNERS GROVEDEC 21 2021 TOWNSHIP, Illinois, for the tax year 2021, collectible in 2022.

BE IT ORDAINED by the BOARD OF TRUSTEES OF DOWNERS GROVE DuPage County Clerk TOWNSHIP, DuPage County, Illinois, as follows:

Section 1: That the sum of TWO MILLION SEVEN HUNDRED FORTY FIVE THOUSAND THREE HUNDRED SEVENTY THREE DOLLARS AND 00/100) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized for the current year, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law for such purposes as the General Fund, General Assistance and IMRF Fund for the fiscal year beginning March 1, 2022 and ending February 28, 2023.
