ORDINANCE NO. 23/24

DOWNERS GROVE TOWNSHIP TAX LEVY ORDINANCE

An ordinance levying taxes for all corporate purposes for DOWNERS GROVE TOWNSHIP, Illinois, for the tax year 2023, collectible in 2024.

BE IT ORDAINED by the BOARD OF TRUSTEES OF DOWNERS GROVE TOWNSHIP, DuPage County, Illinois, as follows:

Section 1: That the sum of TWO MILLION NINE HUNDRED FIFTY NINE THOUSAND NINE HUNDRED AND THIRTY EIGHT DOLLARS AND 09/100) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized for the current year, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law for such purposes as the General Fund, General Assistance and IMRF Fund for the fiscal year beginning March 1, 2023 and ending February 29, 2024.

Section 2: That the amount levied for each object and purpose shall be as follows:

General Fund	\$ 2,834,938.09
IMRF Fund	\$ 25,000.00
GA Fund	\$ 100.000.00
Total	\$ 2,959,938.09

Section 3: That the Clerk shall make and file with the County Clerk of the County of DuPage, on or before the time required by law, a duly certified copy of this ordinance.

Section 4: That if any section, subdivision or sentence of this ordinance shall, for any reason, be held invalid or be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

Section 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
