**TAX LEVY ORDINANCE
DOWNERS GROVE TOWNSHIP ROAD DISTRICT
ORDINANCE NO. 2014**

An Ordinance levying taxes for all road purposes for the Downers Grove Township Road District, DuPage County, Illinois, for the tax year 2014, collectible in 2015.

BE IT ORDAINED by the Board of Trustees of Downers Grove Township, DuPage County, Illinois, as follows:

SECTION 1. That the Highway Commissioner of Downers Grove Township Road District on November 6, 2014, does hereby determine and declare that the sum of Three Million Seven Hundred Ninety Five Thousand One Hundred Fifty Dollars (3,795,150) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

GENERAL ROAD FUND

INSURANCE FUND

SOCIAL SECURITY FUND

ILLINOIS MUNICIPAL RETIREMENT FUND

for the year 2014.






SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of DuPage, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Downers Grove Township Road District.

SECTION 5: That if any section, subdivision or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect its adoption, as provided by law.
