An Ordinance levying taxes for all road purposes for the Downers Grove Township Road District, DuPage County, Illinois, for the tax year 2021, collectible in 2022.

BE IT ORDAINED by the Board of Trustees of Downers Grove Township, DuPage County, Illinois, as follows:

SECTION 1. That the Highway Commissioner of Downers Grove Township Road District on November 18, 2021, does hereby determine and declare that the sum of Four Million Five Hundred Ninety One Thousand Five Hundred Dollars (\$4,591,500 is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:
