# 11. <u>Highway Commission Report</u>

In the past month the Highway Department has been working on the following projects.:

- We spent many hours plowing and salting Twp roads at the end of December. Over the Christmas holiday I called the crew out four separate times and we have been out two other times to just salt roads since then.
- Our tree crew has been busy trimming trees as well as doing cut backs in the right-of-ways along certain roads. Currently we are cutting back our portion of the North I-55 Frontage rd between 79th St and Clarendon hills Rd.

- We also removed a hornets nest that was lodged in a large maple tree in Liberty Park.
- Our patch crew has been busy filling potholes with cold mix. The nice weather we have been having has allowed us to do quite a bit of patching this year.
- We had crews run their routes and pick up Christmas trees for recycling on rain days. This is something we have done every year since we started our brush pick up program back in the late eighties.
- We had our sign crew replace damaged intersection signs that were in need of replacement in several different subdivisions including Brookeridge, the Downers Grove Gardens, 89th St off of Madison St, Farmingdale South and Plesantdale subdivision.
- Crews also spent a couple of days opening up clogged basins before we experienced rain events and replaced sod damaged by the snow plows during plowing. The rain and warm weather gave us a window of time to put in sod in damaged areas. We keep track of damaged areas and follow up with dirt and seed in the spring.
