Supervisor Coultrap stated that on June 10, 2022, Governor Pritzker signed the Decennial Committee on Local Government Efficiency Act (50 ILCS 70). This new law required Illinois Townships, Road Districts and Multi-Assessment Districts and all taxing bodies (except counties and municipalities) to convene a committee to study and report on local government efficiency. Required taxing districts are mandated to hold their first meeting no later than June 10, 2023.

**4. Approval of Citizen Appointees (Resolution 2023-051823-1)**

Attorney Alongi read Resolution 2023-051823-1 into the record. The corporate authority hereby forms a Decennial Committee on Local Government Efficiency under the Act with the following members: 1) Downers Grove Township Board of Trustees; 2) Downers Grove Township Supervisor; 3) Downers Grove Township Office Manager; 4) Downers Grove Township Resident Jasmine Fuentes; and Downers Grove Township Resident Cindy Aguinaga.

Trustee Ferguson made a motion for Approval of Citizen Appointees (Resolution 2023-051823-1). Trustee Ricordati seconded the motion.

Roll Call Vote: Trustee Ferguson, "Aye", Trustee Ricordati, "Aye", Trustee Ockrim "Aye" and Supervisor Coultrap, "Aye". Ayes-4. Nay-0. Absent = 1. Motion carried

Supervisor Coultrap stated that the Act requires that the Decennial Committee meet at least three times.
