

DOWNERS GROVE TOWNSHIP ROAD DISTRICT PUBLIC HEARING HIGHWAY BUDGET

The hearing on Highway Budget (Road District) was called to order at 7:00 PM at the Township boardroom, 4340 Prince St., Downers Grove, IL by Supervisor Thoman. Board members present were Trustee Donner, Trustee Ferguson, Trustee Kelly, Trustee Van Der Laan and Supervisor Thoman. Also present were Allen Alongi, Attorney, Assessor Greg Boltz and Clerk Lorraine Grimsby.

Supervisor Thoman asked for a motion to waive the reading of the legal notice as it had been published in the Downers Grove Suburban Life newspaper, posted in the hallway, on the Township website and copies were available to all attendees. A motion was made by Trustee Van Der Laan to waive the reading of the legal notice for the Road District Public Hearing, motion seconded by Trustee Donner, all voted aye. Motion carried.

Public Discussion: No residents were in attendance for the public hearing.

Attorney Alongi recommended that closing of the Public Hearing be delayed to accommodate any late arrivals.

After a delay, Trustee Van Der Laan made a motion to adopt the Highway Budget and Appropriation for fiscal year 2019-2020 as presented, motion was seconded by Trustee Kelly. Roll call vote: Trustee Donner-aye; Trustee Ferguson-aye; Trustee-Kelly-aye; Trustee Van Der Laan-aye; Supervisor Thoman-aye. Motion carried (5-0).

With no further business to come before the Board, Supervisor Thoman closed the Public Hearing. Meeting adjourned at 7:13 PM.
